## 2. HAZARDS IDENTIFICATION

This material is hazardous according to criteria of Safe Work Australia; HAZARDOUS SUBSTANCE.

### 4. FIRST AID MEASURES

For advice, contact a Poisons Information Centre (e.g. phone Hong Kong 852-34733362) or a doctor.

#### Inhalation:

Remove victim from area of exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. If patient finds breathing difficult and develops a bluish discolouration of the skin (which suggests a lack of oxygen in the blood - cyanosis), ensure airways are clear of any obstruction and have a qualified person give oxygen through a face mask. Apply artificial respiration if patient is not breathing. Seek immediate medical advice.

#### **Skin Contact:**

Wipe excess material from skin with a clean rag or paper towel (do NOT use solvent to clean skin). If skin contact occurs, remove contaminated clothing and wash skin with running water. If irritation occurs seek medical advice.

#### **Eye Contact:**

If in eyes, hold eyelids apart and flush the eye continuously with running water. Continue flushing until advised to stop by a Poisons Information Centre or a doctor, or for at least 15 minutes.

#### Ingestion:

Rinse mouth with water. If swallowed, do NOT induce vomiting. Give a glass of water. Seek medical advice.

#### Medical attention and special treatment:

Treat symptomatically.

### 5. FIRE FIGHTING MEASURES

#### Hazards from combustion products:

Flammable paste. On burning will emit toxic fumes, including those of oxides of carbon.

#### Precautions for fire fighters and special protective equipment:

Keep containers cool with water spray. Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to vapour or products of combustion.

# 6. ACCIDENTAL RELEASE MEASURES

#### **Emergency procedures:**

If contamination of sewers or waterways has occurred advise local emergency services.

#### Methods and materials for containment and clean up:

SMALL SPILLS: Slippery when wet. Avoid accidents, clean up immediately. Wipe up with absorbent (clean rag or paper towels). Allow absorbent to dry before disposing with normal household garbage.

LARGE SPILLS: Shut off all possible sources of ignition. Clear area of all unprotected personnel. Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact and breathing in vapours. Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal. Cured material can only be removed by cutting or abrasion.

### 7. HANDLING AND STORAGE

#### Conditions for safe storage:

Store in cool place and out of direct sunlight. Store in a well ventilated area away from foodstuffs, oxidising agents and sources of heat or ignition. Keep containers closed when not in use - check regularly for leaks.

Avoid skin and eye contact and breathing in vapour. May form flammable vapour mixtures with air. All potential sources of ignition (open flames, pilot lights, furnaces, spark producing switches and electrical equipment etc) must be eliminated both in and near the work area. Do NOT smoke. Vapour may travel a considerable distance to source of ignition and flash back.

### 8. EXPOSURE CONTROLS/PERSONAL PROTECTION

**Occupational Exposure Limits:** No value assigned for this specific material by the National Occupational Health and Safety Commission. However, Exposure Standard(s) for constituent(s):

Acetone: 8hr TWA = 1185 mg/m3 (500 ppm), 15 min STEL = 2375 mg/m3 (1000 ppm)

Heptane: 8hr TWA = 1640 mg/m3 (400 ppm), 15 min STEL = 2050 mg/m3 (500 ppm)

Methyl acetate: 8hr TWA = 606 mg/m3 (200 ppm), 15 min STEL = 757 mg/m3 (250 ppm)

TWA - The time-weighted average airborne concentration over an eight-hour working day, for a five-day working week over an entire working life.

STEL (Short Term Exposure Limit) - the average airborne concentration over a 15 minute period which should not be exceeded at any time during a normal eight hour work day. According to current knowledge this concentration should neither impair the health of, nor cause undue discomfort to, nearly all workers.

These Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept to as low a level as is workable. These exposure standards should not be used as fine dividing lines between safe and dangerous concentrations of chemicals. They are not a measure of relative toxicity.

#### **Engineering controls:**

Ensure ventilation is adequate and that air concentrations of components are controlled below quoted Exposure Standards. Vapour heavier than air - prevent concentration in hollows or sumps. DO NOT enter confined spaces where vapour may have collected.

### 11. TOXICOLOGICAL INFORMATION

No adverse health effects expected if the product is handled in accordance with this Safety Data Sheet and the product label. Symptoms or effects that may arise if the product is mishandled and overexposure occurs are:

**Ingestion:** Swallowing can result in nausea, vomiting and central nervous system depression. If the victim

is showing signs of central system depression (like those of drunkeness) there is greater

likelihood of the patient breathing in vomit and causing damage to the lungs, reathing in vomit

may lead to aspiration pneumonia (inflammation of the lung).

No adverse effects expected after swallowing cured (solvent free) sealant.

**Eye contact:** An eye irritant.

**Skin contact:** Contact with skin may result in irritation. Will have a degreasing action on the skin. Repeated or

prolonged skin contact may lead to irritant contact dermatitis.

**Inhalation:** Material may be irritant to the mucous membranes of the respiratory tract (airways).

Breathing in vapour can result in headaches, dizziness, drowsiness, and possible nausea. Breathing in high concentrations can produce central nervous system depression, which can lead to loss of co-ordination, impaired judgement and if
